

FCCLA CREED & PROCEDURES

JUNIOR AND SENIOR DIVISIONS INDIVIDUAL EVENT

TIME: Twenty (20) question quiz, in approximately thirty (30) minutes.

All participants are tested at once.

Creed recitation and questions approximately fifteen (15) minutes.

PURPOSES:

1. To assist members in developing their knowledge concerning FCCLA purposes, traditions, policies and procedures.
2. To strengthen each member's knowledge and to assist them in marketing FCCLA to administrators and community leaders.
3. To assist members in becoming familiar with national programs, STAR and State Proficiency Events.

SPECIFICATIONS:

1. Previous awardees for this event are ineligible to compete for a second time.
2. All questions will be derived from State and National publications.
3. Members will be required to recite the FCCLA Creed from memory, without the assistance of notes.
4. Members will demonstrate their knowledge by completing an oral interview and a written evaluation.
4. During the creed presentation and oral interview, only the event participant may be in the room. This section of the event is closed to the public.
5. In order to participate in this event, you must check in with the officer in charge to receive an appointment time for the oral interview and creed recitation. Meet the officer at the beginning of the time period slated for the Creed & Procedures Event.
